## Consent Sheet



### Gift Aid Donation

Please participate in the Group's Gift Aid Scheme, which allows the Group to reclaim tax on any qualifying donation, regardless of whether it is regular payment or a one off.

The declaration below is not a legal document and does not ask you to commit to paying the membership subscription for a set period, and you can cancel your declaration at any time, by notifying the Group.

- Notes
1. You must pay an amount of income tax or capital gains tax at least equal to the tax we reclaim on the payments (currently 28p for every £1 you give).
  2. You can cancel this declaration at any time by notifying the Scout Group.
  3. Please notify the Scout Group if you change your name or address.
  4. If you pay tax at the higher rate you may be able to claim further tax relief via your Self Assessment Tax Return.

### Membership Records

Legislation came into force in March 2000, which covers the protection and processing of personal data. Adults and young people have the same rights under the Data Protection Act, which covers paper based, as well as computer based information. Certain information is classed by the law as 'Sensitive Personal Data'; in a Scouting context this may include information about your child's:

- contact information – *so that we can get hold of you, should we need to do so*
- health & well-being - *so that we are prepared for medical emergencies*
- disabilities - *to make sure that your child's participation in activities is safe*
- religious or similar beliefs - *to help us to make appropriate arrangements, when necessary*
- racial or ethnic origin – *so that we are sensitive to their cultural needs*

To hold this 'Personal Data', and other details, we need your explicit approval. None of the information held by the Group will be disclosed to third parties outside the Scout Movement, without your consent.

### Images

Sometimes photographs, digital and/or video images of Members of Wedmore Scout Group taking part in activities are used within the Scout Group, in District or County Newsletters and/or websites, are submitted to the local newspapers, or are put on display.

To store and use these types of images of your child we need your explicit consent.
